

# Picnic Facility Rules and Regulations

- Pavilions are reserved on a first-come first-served basis. Individuals, families, and organizations who wish to reserve the pavilions must make the appropriate arrangements through the Park Office. **Please Note:** A modest fee is typically assessed for the use of the park's picnic facilities. In addition, certain activities require proof of insurance and a Special Use Permit. Reservations, Special Use Permits, Etc. are available through the Park Office.
- **Alcoholic beverages are prohibited.**
- Open fires are prohibited.
- Playing loud music, yelling, screaming and/or the use of profanity is prohibited.
- No loitering after hours. **Park hours are from sunrise to sunset daily, unless otherwise posted.**
- Hot Coals must be extinguished at the conclusion of your event and are to be placed in the Hot Coal Cans provided.
- Hot Coals are not to be placed in the trash receptacles.
- All refuse is to be disposed of in the trash receptacles (and/or dumpster) provided. Do not place trash in the Hot Coal Cans for any reason.
- Nailing, screwing and/or stapling into any portion of the pavilions for the purpose of hanging banners, signs and/or decorations is strictly prohibited.
- The use of staples, nails and/or thumbtacks to secure table cloths to the wooden picnic tables is prohibited. Tape and/or reusable plastic "table cloth clips" are recommended.
- Skateboarding around/under the pavilions is prohibited. Skateboarding is permitted on paved surfaces.
- Driving on the grass is prohibited. Vehicles will remain in paved parking areas unless otherwise directed by Park Staff.
- Driving stakes and/or digging holes in the lawn areas surrounding the pavilions is strictly prohibited due to the presence of shallow sub-surface electrical lines.
- Pets must remain on leash and must be attended to by their owner at all times. In addition, all pet waste must be cleaned up and properly disposed of.
- No alterations to the facility/grounds can be made without the expressed written consent of the Park Supervisor and/or his designee.
- The use of confetti and/or uncooked rice for parties and/or weddings is prohibited. The use of birdseed is recommended.
- Picnic tables are provided for the consumption of food, display and/or relaxation (sitting) purposes only, please keep this in mind when using the Park's facilities.
- Graffiti of any type is strictly prohibited. This includes the use of sidewalk chalk.
